Red Roses for the White Queen



Former SDMC member and my erudite friend, Larry Clark enjoyed sharing his theory explaining our heightened fascination with the color of our cars. While Larry passed away multiple years ago, his explanation remains relevant even now. Let's see if this resonates with you as well.

Perhaps you can remember, or imagine, the in-

four or five years into the first generation, the NA. (Doubtful the initials stood for "No Argument." - Ed.) Toss in the NB and the argument broadens to include 200 additional cubic centimeters of displacement and fixed versus "winking" headlamps. I know ... I know ... there were other refinements, but not the huge departure in style and substance that characterizes some other generations of sports cars. Think Corvette, Porsche, let alone the Italian offerings. You'd be right to argue that Porsche has stuck with the basic 911 chassis since retiring the 356, but consider the permutations and combinations.

With the advent of the NC and ND - 3rd and 4th generations, respectively, we began to see some different chassis and engine combinations, even roof options. The RF marks a significant change in body configuration, but the underpinnings are "off the shelf." Something more substantive to talk about, and I would argue that color was beginning to take a "back seat." Hosting as many monthly meetings as I did, and in introducing new members to the audience, I always tried to elicit responses that avoided the classic "what color is your Miata?" Thinking I simply forgot, someone in the audience always asked. Rather than fueling this colorful debate any further, my real preference is that we focus on the substance of our vehicles rather than the make-up and outward appearance. Is it too late to apologize?

Rolling Loud and Proud ... What Did You Say?

Typical of most new years in California, there's usually a brace of new laws pertaining to our operation of motor vehicles. One of the rules taking effect January 1, 2019, was one changing the way law enforcement can deal with exhaust noise violations. The legislation in question is California Assembly Bill 1824, and you may have heard the buzz, since many in the car community seem pretty upset about it.

According to the article I read at Jalopnik.com, some of that "noise" may be unfounded. You can read the full article for yourself at <https://jalopnik.com/why-people-are-suddenly-freaking-out-over-californias-e-1831620651>. Or, trust me to help break it down for you. (Any opinions of the author do not constitute legal advice, yada, yada, yada – Ed.) Like most California Vehicle Codes, those governing vehicle exhaust have been strict for a long time. AB 1824 doesn't really change existing laws regulating exhaust noise or the sale and installation of aftermarket exhaust systems. It only deals with the enforcement aspects; it did become a lot easier to assess an immediate fine, instead of issuing the traditional fix-it ticket.

According to the Specialty Equipment Market Association (SEMA) press release on the subject, here are the particulars you need to know:

- ◆ Under existing law, exhaust systems installed on motor vehicles (GVW rating < 6,000 pounds, other than motorcycles), may not exceed a sound level of **95-decibels** when tested under Society of Automotive Engineers (SAE) test procedure J1169 (May 1998). And tested at a distance of 50 feet from the centerline of travel.

According to the Specialty Equipment Market Association (SEMA) press release on the subject, here are the particulars you need to know: (cont'd)

- ◆ For reference, how loud is 95 decibels?
 - Boeing 737 or DC-9 aircraft at one nautical mile (6080 ft.) before landing (97 dB)
 - Gas-powered mower (96 dB)
 - Motorcycle at 25 ft. (90 dB)
 - Newspaper press (97 dB)
- ◆ Existing law requires every motor vehicle (those subject to registration) to be equipped with an adequate muffler in constant operation and properly maintained to prevent any excessive or unusual noise and prohibits a muffler or exhaust system from being equipped with a cutout, bypass, or similar device.
- ◆ Existing law further prohibits the modification of an exhaust system of a motor vehicle in a manner that will amplify or increase the noise emitted by the motor of the vehicle so that the vehicle exceeds existing noise limits. (See photo on page 3)
- ◆ The Golden State cares about two things when it comes to our vehicle exhaust – how much it pollutes and that it's not too loud. Biannual smog testing addresses the former; law enforcement officers address the latter.
- ◆ Per California Highway Patrol Bulletin NO.98-100: "Excessive Noise is primarily a nuisance issue rather than a safety concern, and determination of excessive noise is subjective. For this reason, enforcement personnel are to exercise sound (no bureaucratic pun intended) professional judgment in making a determination of violation."
- ◆ But technically speaking, the California

Vehicle Code says SAE J1169 is the measurement standard. That means the exhaust noise should be measured at a constant RPM. Perhaps we'll see more information about the testing methodology.

Conclusion: AB 1824 has made it a lot easier for law enforcement to issue a citation and fine if you are breaking the existing rules. Don't expect the time-honored tradition of a fix-it ticket to apply. At the same time there are specific rules on what constitutes "too loud," the measurement standards seem to be in flux. Applying the "nuisance" rule (above) and the police officer's sense of what constitutes 95 decibels in the field definitely leaves some *grey* (Ahem. – Ed.) area.

Appreciate the "flop" whenever you recognize it. Live loud and colorful in the coming months!
